
A. GENERAL INFORMATION:

1. The process of PB UMKU Certificate of Telecommunication Equipment and/or Equipment through the OSS Institution is for new applications, while only intended applications for Revision/Repair Transfer of Certificates are still carried or through the E-Certification application of the Directorate General of SDPPI on the website https://sertifikasi.postel.go.id for more information.


- 2. The requirements and types of KBLI that have been determined for PB UMKU Certificate of Telecommunication Equipment and/or Equipment can be seen at the following link https://oss.go.id/informasi/umku. If the business actor does not have one of the 74 types of KBLI, it is necessary to amend the Deed of Business Entity for further NIB renewal.

B. GUIDELINES FOR APPLICATION FOR CERTIFICATE OF TELECOMMUNICATION TOOLS AND/OR DEVICES

Make sure you have a risk-based NIB obtained on the page https://oss.go.id/




2. Login to the OSS application and select "PB-UMKU" to submit a New Application for Telecommunication Equipment and/or Equipment Certificate



3. Determine the KBLI to be submitted, then select "UMKU Business Licensing Process".



4. Apply for UMKU Business Licensing and select Telecommunication Equipment and/ or Equipment Certificate



Click Next to continue




5. If successful, OSS will provide a Permit ID which then needs to be done "Fulfillment of PB UMKU Requirements in the K/L System"



6. When "Fulfillment of PB UMKU Requirements in the K/L System" is selected, it will automatically be connected to the E-Certification application of the Directorate General of SDPPI of the Ministry of Communication and Information.




7. Automatically, the system sees whether the NIB, PLG ID or email account has been previously recorded on the DG SDPPI E-Certification application, so NIB Confirmation is necessary.



If the email address data used in the E-Certification Application is different from the email address on the OSS, then the PLG ID application needs to be re-verified by the Directorate General of SDPPI.

8. When the NIB Confirmation has been successfully carried out, "Fulfillment of PB UMKU Requirements in the K/L System" will display the OSS LICENSE ID as identification of the Certificate application, then input the Certificate application data by selecting the IZIN ID.
